**A BY-LAW TO AMEND SCHEDULE "A" TO BY-LAW 08-32 BEING A BY-LAW TO ADOPT THE 2008 ESTIMATES AND SET RATES OF TAXATION FOR COUNTY PURPOSES FOR THE YEAR 2008**

**WHEREAS** the Ministry of Transportation has confirmed that the United Counties of Leeds and Grenville will receive funds in the amount of \$3,585,735.00 to be used for municipal road and bridge capital investment needs; and

**WHEREAS** these funds were budgeted as revenue with a corresponding transfer to reserve as part of the 2008 Budget passed on April 24, 2008; and

**WHEREAS** the Public Works Committee has recommended that these funds be used for modifications/additions to 2008 Public Works Capital Projects:

**NOW THEREFORE THE COUNCIL OF THE UNITED COUNTIES OF LEEDS AND GRENVILLE HEREBY ENACTS AS FOLLOWS:**

1. **THAT** Schedule "A" to By-Law 08-32 is amended by moving \$3,585,750.00 from Reserve to the Capital Budget to allow for the following modifications and additions to the Roads Capital Program:



County Road #44 – Clothier St. to County Road #43	\$60,000.
County Road # 3 - Outlet Bridge	\$ 120,000.

County Road #16 – Irish Creek Bridge	\$ 75,000.
County Road #23 – Unnamed Bridge East of Merrickville	\$ 162,000.
County Road # 32 – Gananoque Bridge	\$165,000.
Spencerville Garage Retrofit	\$ 175,000.
Replace one (1) Wheel Loader	\$ 228,750.





